The legal profession in Korea

A- History of the Bar system of Korea

I/ Birth of the Bar system

'ne Bar system **in** Korean was bom on November 8, 1905 (the ninth year of Gwagmu). Th- is lawyer Act **is** usually,called the Gwangmu Lawyers Act. The Lawyers Act regulated the Bar system **in** the following ways:

- 1. 1. Qualification and authorization of lawyers
- 1.2. The functions and discipline of Lawyers

And the Lawyers Act was amended by Law No, 1 8 on April 26,1909 in accordance with the refon-nation of Judiciary Composition Act in 1907.

- II/ The bar system under Japanese colonial rule and the U.S Military Government
 - 1. The Bar system under Japanese Colonial Rule: Lawyer's regulation is called the Chosun Government General's la%,v%,ers regulation.

A special characteristic of the U.S. military Government's lawyers Act was the person having serves full time professors for seven years or more and who were authorized by the Minister of Justice were recognized as having qualifications as lawyers *.R The* **Bar** *system of* **the** *Republic of Korea*

 - The lawyer Act was promulgated as Law No.63 on November 7, 1949. The Act, which consisted of 47 Articles.
- 2. Amendment of the lawyers Act

The lawyer Act has been amended seven times. The current Acts as wnended by Law No.4544 of March 10,1993

- D. The Mission and functions of linvyers I/ The mission of lawyers

The mission of lawyers is to protect basic human rights and attain social Justice. And

endeavor to preserve social order and the improvement of the legal system.

2/ -ne Function of lawyers

- The functions of lawyers are to perform, by way of appointment of the concerned party or other related person or the commissioning by a public agency.
- Act as to litigation and acts on the persons' behalf as to demands for administrative disposition as well as perform regular legal work.
- Lawyers may also perform notaries services and have qualifications as patent attorney.
- E. Rights and Responsibilities of Imvyers I/ @ghts of Lawyers

Lawyers are entitled to be attorneys, defense counsel, assistants and representatives in

every kind of lawsuit such as civil cases, criminal cases, administrative cases or domestic relations cases, etc.

- And according to the Lawyers Act, lawyers may establish law offices and the law office shall be located in he **district** of the bar association to which he belongs.

2/ Responsibilities of lawyers

- Responsibility to conduct the designated work
- Responsibility to obev Bas association by laws
- Restriction on taking cases

E The supervision of and disciplinary Actions against Imvyers

I/ The Supervision of lawyers

- Lawyers shall receive the supervision of the local bar association to which he belongs, the Korean bar association and the Minister of Justice.
- The local bar association shall receive the super-vision of the Korean bar association and Minister of Justice.

2/ Disciplinary Measures against lawyers

- Disciplinary measures are four different types: disablement, suspension of license, civil fines and

reprimands.

G. Judicial Corporations (JC)

I/ Establishment

- Lawyers may establish a JC for providing systematic and specialized legal practices. - A lawyer 'oining a JC must obtain an authorization from the Minister of Justice.

- A JC is dissolved for following reasons: (1) occurrence of causes deten-nined in the articles of incorporation-. (2) merger- (3) bankruptcy; (4) or cancellation of the

authorization.

2/ The manner of handling business by JCs

And JC may set up branch offices outside of the main office and shall report to the

Minister

of Justice.

- JC perform work that comes under the function of lawyers and notaries public.
 - JC shall perfon-n work in the name of the corporation and shall designate the lawyers

to be in

charge of work.

H. Law office authorized to conduct Notaries Services.

I/ Establishment: Lawyers may establish a Law office Authorized to conduct Notaries Services (Law office for

Notaries Services) for performing notaries services as such are provided for in the Notaries Act. 2/ The manner of handling Businesses - In discharging works, a law office for notaries service should prepare documents for

notarial

- services in the name of the office.
- The members of a law office for notarial services shall be equally liable for debts

owed by

the office.
